1.0 CALL TO ORDER

1.1 Pledge of Allegiance

President Madison Martin called the meeting to order at 4:02 p.m. in the 345 5th Street, Colusa, Large Conference Room and led the Pledge of Allegiance.

4.0 LETTERS AND COMMUNICATIONS

4.1 Years of Service Awards, 2023

Michael West recognized the following CCOE employees for their years of service: Merry Hofhenke (Special Education) and Vicki Markss (Children's Services). The following were not in attendance and will be recognized later: Cara Erickson (Special Education), Rosa Estrada (Food Services), and Ashley Page (Special Education).

4.2 YCCD update - Susan Alves, Trustee - Area 6

Michael West introduced YCCD Trustee Area 6 and Vice President of the Board, Susan Alves. Susan shared YCCD updates, her goal for increasing Colusa County representation on the YCCD Foundation Board, and she provided a prospectus for the new Woodland Community College President selection. Discussion was held on offering more classes at the WCC Colusa Campus and providing vocational classes as well, the timeline for the president selection, on Colusa Board of Education forming a joint committee with Lake County Board of Education, on the lack of communication with previous YCCD trustees, and on Susan and Brenda Miller scheduling a meeting together.

6.0 REPORTS FROM SUPERINTENDENT AND STAFF

6.1 Superintendent's Reports

6.1.1 Superintendent's Monthly Report

Michael reported on his participation and attendance in activities, such as a meeting with Colusa County Sheriff's Department regarding SARB, which will hold its first hearing on September 18, 2023; the NCAEC Executive Committee meeting in Williams that detailed the budget, planning, and future direction of Adult Education for the five-county area; the CSR 3 Annual Planning meeting, a K12HSN meeting to discuss the impacts of new cyber-attacks, current projects, and the impact of Al across all mediums of the K12HSN; the Head Start Policy Council meeting; a demonstration of a virtual reality/augmented reality program offered by a company called Oasis XRE that could be used for credit recovery, as a tool to reduce chronic absenteeism, and provide CTE components for students and adults; the CCBE Annual Conference also attended by Madison Martin and Serena Morrow, during which he participated in the F2B presentation; a meeting with Dr. Danielle Thomas about F2B, ALFA, plans for the future of CCOE's Pre-School staff and Private Pay Child Care Providers certification program, and a continued partnership with San Benito COE in expanding CCOE's ALFA Certification Project. Michael spoke about the California LAO's report that provided conflicting information on the State Budget, which not much is known about until taxes are collected in October and perhaps not until the end of November. Michael also provided a legislative update on the following:

HR 4519	IDEA Full Funding Act to bring federal government excess cost support to 40%, as originally promised, by 2033.
AB 247	TK-14 Public Education Facilities Bond Act of 2024, to provide \$14 billion to construct and modernize education facilities.
AB 715	Rural Education Task Force to be created at the CDE to assist and advise the State Superintendent on the needs and challenges of rural schools.
AB 906	LCFF increased support for alternative education.
AB 1699	K-14 Classified employees' rights expansion.
SB 88	Pupil transportation: Driver qualifications to place health, safety, and security requirements on drivers and vehicles.

6.1.2 Superintendents Council - August Meeting

Michael West reported that he met with the district Superintendents in August and welcomed Jeff Ochs, Superintendent/Principal from Princeton, who will be joining the group for monthly meetings. Afterward the Superintendents discussed fiscal education opportunities through the SchoolsFirst Credit Union; LCAP changes, specifically the Student Advisory Group requirement; requesting California County Superintendents advocacy for TK facilities, TK enrollment flexibility, and 60-day expansion of the 30-day Substitute Teaching Permit Flexibility;

and the end of Sutter COE's NorCal Substitute Consortium, which CCOE's HR department is on a fast track to take over the duties as Colusa County Substitute Consortium.

6.2 Administrative Services – Aaron Heinz

Aaron Heinz was not present.

6.3 Student Services – Chuck Wayman

Chuck Wayman deferred to Vicki Markss to answer the Board's question regarding his September 2023 Student Services written report, about Children's Services classified employees' recent CSEA labor representation. Sabrina Myers said that the CSEA representative has not reached out to her yet, and when they do both sides will build the bargaining unit.

6.4 Technology Services - Alex Evans

Alex Evans answered the Board's questions regarding his September 2023 Technology Services written report, about whether AI is a part of cyber-attacks, saying the reason that the attacks are so brutal is because of AI. Alex said that to counter attacks, CCOE implemented two-factor authentication. He said that attackers are often going for identity theft and often result in system outages in order to thwart the attacks. Alex said that fail safes include offsite storage, data encryption, isolating systems to localize damage, adding that these measures cost both time and money. Alex reported that CCOE's newest Technology Services employee is currently taking a cyber security class.

Serena Morrow reported on the CCBE Annual Conference including information on liaison appointments and board calendars.

Madison Martin reported on the conference including her attendance at ten presentations. Madison updated the Board on the Policy Platform Committee, of which she is a member, that is recommending a facility bond to make all play areas ADA compliant.

10.1 Community College District Territory (standing item)

Michael West reported that he met with YCCD Chancellor Dr. Shaun Pan at the Village and that they discussed Dr. Pan's vision for the coming year, reviewed needs of Colusa County and WCC, and then toured the Village.

10.2 Facilities Update (standing item)

Michael West reported that all four portables have been placed and painted at the Village, the new portable for the Village should be arriving any day, and that the new hire in MOT and the new Farm to School Instructor have been doing an excellent job at keeping the landscape in order. Discussion was held on the tractor at the Village.

10.3 LCAP Update (standing item)

Educational Services Assistant Superintendent John Ithurburn reported that CCOE and all districts' LCAP are in, and all are good.

10.4 Universal Prekindergarten (standing item)

Children's Services Director Vicki Markss reported on UPK activities including attendance at a UPK Community Circle, which held discussions on report cards, progress reports, and assessments using the DRDP; toileting (potty training); and nap time. Discussion was held on staffing, and Vicki said that Children's Services currently has 16 Associate Teacher vacancies and she reported on an "On the Spot" hiring event on September 14 with One-Stop. Vicki added that CCOE will be opening a new 0- to 3-year-olds facility. Sabrina Myers spoke about offering the paraeducator assessment test (CODESP) on Saturdays and on plans for future hiring events.
